Whereas vide Government order No 264 PDD of 2012 dated 5.9.2012, based on Cabinet Decision, sanction has been accorded to the unbundling of the Jammu and Kashmir Power Development Department and setting up of one State Transmission Company (J&K Transco), two Distribution Companies, one each for Kashmir and Jammu Divisions and one J&K Tradeco with Holding Company function under the Companies Act-1956 in accordance with laid down procedure.
